# Oregon AFL-CIO Convention Delegates



General information and instructions on how to submit questionnaire

Every two years the Oregon AFL-CIO holds its biennial convention and, as an affiliate of AFT and the Oregon AFL-CIO, OSEA has full membership status at its convention. OSEA Board Policy 1805, State AFL-CIO Delegate Election, lays out the process for electing OSEA delegates and alternates. Each of the 10 members of the OSEA Board of Directors is an automatic delegate. Additional delegate positions will be elected on a statewide, at-large basis at OSEA's annual Conference from among active members and active ROSE members.

## **Candidate qualifications**

All candidates must be members in good standing as defined in Article III, Section 2, of the OSEA Constitution for at least one year prior to the election or active ROSE members in good standing as defined in Article VI, Section 4, of the Constitution.

Members elected as delegates or alternates will be considered ambassadors for OSEA and, therefore, should be knowledgeable about OSEA programs, issues and its political agenda. Candidates are required to submit this completed questionnaire itemizing their applicable background and experience in OSEA, the labor movement, political activities and community activities in order to be considered by the delegate body. Any section left blank will constitute an incomplete questionnaire.
